RULES

1. Referees decisions are final. There are no protests.
2. Each team will be guaranteed 2 matches. A match will consist of best of three games. A game consists of 11 points or 10 minute time limit. A team must win by 2 points.
3. The ball must be served from inside the pit from the right back corner and may be hit in any manner with the hand. Prior to service, the ball may not be loaded with mud.
4. It is a foul for players to touch the net.
5. A point may be scored only by side serving.
6. Players of the serving team must rotate clockwise when receiving the ball to serve, and the right back must serve.
7. Holding or throwing the ball while it is in play is a foul. The play must be distinct batting of the ball.
8. Three hits to a side. A player may not hit the ball twice in succession. A block is not considered a hit.
9. A ball may be played by any part of the body above the waist.
10. It is a violation to spike with two hands.
11. Only the front line is permitted to spike.
12. Everyone participating must wear tennis shoes. Protective eyewear is recommended.
13. Any player arguing with or abusing an official will be asked to leave the game and immediate vicinity. Failure to leave will cause his/her team to forfeit the match. A player ejected from a match will not be allowed to participate in any further matches.
14. Officials will be provided.
15. Rules are subject to referee's interpretation.
16. A team can only have a maximum of eight players on the court at one time.
17. At least two females and two males must be on the court from each team at all times.
18. Substituting will only be allowed from the serving team, except in case of injury.
19. The court shall consist of a net and genuine Pasadena mud, 60' x 30'.
20. A team representative must attend the registration meeting **Thursday, May 13th**, at 6:00 pm at the Pasadena Fairgrounds.
21. Tournament limited to 128 teams.
22. No time outs allowed except in case of injury.
23. Any ball hitting the water and making a splash is considered in. In bound areas to be interpreted by individual referees prior to each match.
24. No Phone-in Entries.
25. **Must be at least 18 years old to play.**
26. **No food, beverage, drink, or ice chests of any kind can be brought on to the grounds.**

Mud Volleyball Tournament Waiver
