ACKNOWLEDGMENT: In consideration for allowed entry into and participation in all activities associated with the Pasadena Strawberry Festival ("PSF"), I RELEASE and INDEMNIFY PSF and their present and former officers, directors, members, staff, and agents from all claims that may accrue to me as a result of entry into and participation thereof. I further acknowledge and understand that I will be held liable and responsible for any and all damages to livestock, vehicles, property, and/or improvements to property caused by me and/or persons, including minor(s) under my care and control.

RELEASE FROM LIABILITY: In consideration described in this agreement, I hereby RELEASE and WAIVE any claim against PSF, their present and former officers, directors, members, staff, and agents for damages or injuries, and agree not to sue PDF. I further agree that the PSF shall not be liable to me, my family, or my guests for personal injury, property damage, or any losses. I understand that this Release and Indemnity Agreement shall be binding on my heirs, executors, successors and assigns. THIS RELEASE AGREEMENT INCLUDES, BUT NOT LIMITED TO LOSSES CAUSED BY ANY OF THE FOLLOWING: NEGLIGENCE, GROSS NEGLIGENCE, NEGLIGENCE PER SE, AND/OR STRICT LIABILITY OF PSF, ACTS UNDER THE TEXAS DECEPTIVE TRADE PRACTICES ACT ("DTPA") OR ACTS OF ANY OTHER PERSONS, GUESTS, THEFT, BURGLARY, ASSAULT, CRIMES, FIRE, WATER, WIND, RAIN, SMOKE AND/OR RISKS AND HAZARDS BOTH WILD AND DOMESTIC THAT MAY BE DISEASED AND/OR POTENTIALLY DANGEROUS, PERSONS WITH FIREARMS BOTH ON AND OFF THE PREMISES, AND THE DRIVING OR RIDING IN ANY VEHICLES, WHETHER BELONGING TO PSF OR TO OTHER PERSONS.

AGREEMENT TO INDEMNIFY AND HOLD HARMLESS: IN FURTHER CONSIDERATION DESCRIBED IN THIS AGREEMENT, I AGREE TO INDEMNIFY AND HOLD HARMLESS PSF, THEIR PRESENT OR FORMER OFFICERS, DIRECTORS, MEMBERS, STAFF AND AGENTS, AND AGREE TO BE BOUND TO DEFEND OR PAY JUDGEMENTS AGAINST THEM FOR ANY AND ALL LOSSES, CLAIMS, DEMANDS, OR CAUSES OF ACTION, COSTS OF DEFENSE OR SETTLEMENT, INCLUDING BODILY INJURY OR DEATH CAUSED BY NEGLIGENCE, GROSS NEGLIGENCE, NEGLIGENCE PER SE, STRICT LIABILITY AND/OR LIABILITY UNDER THE DTPA, OF PSF, OR FOR WHATEVER OTHER REASON. SPECIFICALLY, I AGREE TO INDEMNIFY PSF INCLUDING COSTS OF DEFENSE OR SETTLEMENT, FOR ANY LIABILITY TO A MINOR UNDER MY CARE AND CONTROL AND/OR HIS OR HER PARENT/GUARDIAN DUE IN THE NEGLIGENCE, GROSS NEGLIGENCE, NEGLIGENCE PER SE, STRICT LIABILITY UNDER THE DTPA, OR ANY ACT OR OMISSION OF PSF AND/OR OTHER PERSONS. TO INDEMNIFY means to agree to assume the liability in a situation thereby relieving the other party of responsibility.

PHOTO/VIDEO/INTERVIEW RELEASE AND INDEMNITY AGREEMENT: In further consideration described in this agreement, I GRANT PERMISSION to be PHOTOGRAPHED, VIDEOED or INTERVIEWED in connection with the PSF. I understand that any such photograph, video or interview may be used by television, film, video, visual, graphic, printed, or social media to demonstrate the nature of the PSF and to further the aims of the PSF.

I AGREE TO RELEASE AND INDEMNIFY THE PSF FOR ANY NEGLIGENCE, GROSS NEGLIGENCE, NEGLIGENCE PER SE, STRICT LIABILITY AND/OR LIABILITY UNDER THE DTPA, OR ANY ACT OR OMISSION OF PSF OR OTHER PERSONS, INCLUDING BUT NOT LIMITED TO LOSSES, CLAIMS, DEMANDS, CAUSES OF ACTION, COSTS OF DEFENSE OR SETTLEMENT, RELATED TO THE USAGE OF SUCH PHOTOGRAPHS, VIDEOS OR INTERVIEWS BY THE PSF.

Warning: Under Texas Law (Chapter 87, Civil Practice and Remedies Code), a livestock show sponsor is not liable for an injury to or the death of a participant in a livestock show resulting from the inherent risk of livestock show activities.

THIS AGREEMENT REQUIRES ME TO RELEASE AND IMDEMNIFY PASADENA STRAWBERRY FESTIVAL FROM ANY CLAIMS THAT MAY ARISE OUT OF THE NEGLIGENCE OR FAULT OF THE PASADENA STRAWBERRY FESTIVAL.

Minimum age is 3 and max weight limit is 70 pounds. Long pants and closed toed shoes are recommended. Helmets will be provided.
